USR - Indicates the air heaters were investigated to the Standard for Electric Heating Appliances, UL 499, Twelfth Edition.

 ${\tt CNR}$ - Indicates the air heaters were investigated to the Canadian Standard CAN/CSA C22.2 No. 88-1958.

This appliance is for use with industrial control panels, control boxes, etc. It will be mounted within the enclosure to keep the internal temperature at a suitable level.

The heater is for use only in complete equipment where the acceptability of the combination is determined by Underwriters Laboratories Inc.

CONDITIONS OF ACCEPTABILITY

Some of the features which should be considered in determining the acceptability of this heater in the specific applications are indicated below:

- 1. The heater is intended for use within an enclosure. The suitability is to be determined in the end-use.
- 2. These heaters are not intended for use in free air.
- 3. Maximum aluminum surface temperature was 103°C in an open air ambient of 25°C. The need for an enclosure, guards or marking should be evaluated in the end-use.
- 4. The suitability of the cord, strain relief, cord connection method and proximity to hot surfaces should be evaluated in the end-use.
- 5. The mounting of the product must be evaluated in the end use.
- 6. The terminal block is suitable only for 20-14 AWG.
