EU RoHS Declaration

Dear Sirs and Madams,

EU RoHS (→ *Restriction of (the use of certain) Hazardous Substances* in electrical and electronic equipment) limits as an EU internal market directive, the usage of the substances listed below for the manufacturing and processing of electrical and electronic equipment and components with regard to exceeding the specified threshold value per homogeneous material level (see % data in the list below), taking into account allowed exemptions (according to RoHS 2011/65/EU Annex III + IV).

The current EU RoHS is based on Directive 2011/65/EU of the European Parliament plus the delegated EU Directive 2015/863 which has expanded the six previous EU RoHS substances by four additional ones, namely **Phthalates**:

- Lead (0.1%)
- Mercury (0.1%)
- Cadmium (0.01%)
- Hexavalent Chromium (0.1%)
- Polybrominated Biphenyls (PBB) (0.1%)
- Polybrominated Diphenyl Ethers (PBDE) (0.1%)
- **Bis(2-ethylhexyl) Phthalate (DEHP) (0.1%)**
- **Butyl Benzyl Phthalate (BBP) (0.1%)**
- **Dibutyl Phthalate (DBP) (0.1%)**
- **Diisobutyl Phthalate (DIBP) (0.1%)**

This EU RoHS amendment (→ <https://rohsguide.com/>) took effect on the 22nd of July 2019. Besides, Directive (EU) 2017/2102 brought amendments concerning the extension of exemptions from substance restrictions, changing the deadline within which to decide on the extension of an exception, the duration of exceptions for EU RoHS Category 11 (= other electrical devices/products that cannot be assigned to any of the other 10 EU RoHS Categories and have not previously been subject to the EU RoHS scope) and the re-use of spare parts.

We feel a deep commitment to our environment. In other words, constantly improving our company means reducing our environmental impact. According to our present state of knowledge and based on the information from our own suppliers so far, we hereby declare that STEGO products comply at that stage with the current EU RoHS Directives. The allowed exemptions 6(a), 6(a)-I, 6(b), 6(b)-I, 6(b)-II, 6(c), 7(a), 7(c)-I and 15 are hereby applied for Lead and Lead compounds, according to RoHS 2011/65/EU Annex III. We provide such information "AS IS" to you, without any express or implied warranties.

We reserve the right to update and modify this declaration, as we believe necessary or appropriate.
